IMnI's Objectives

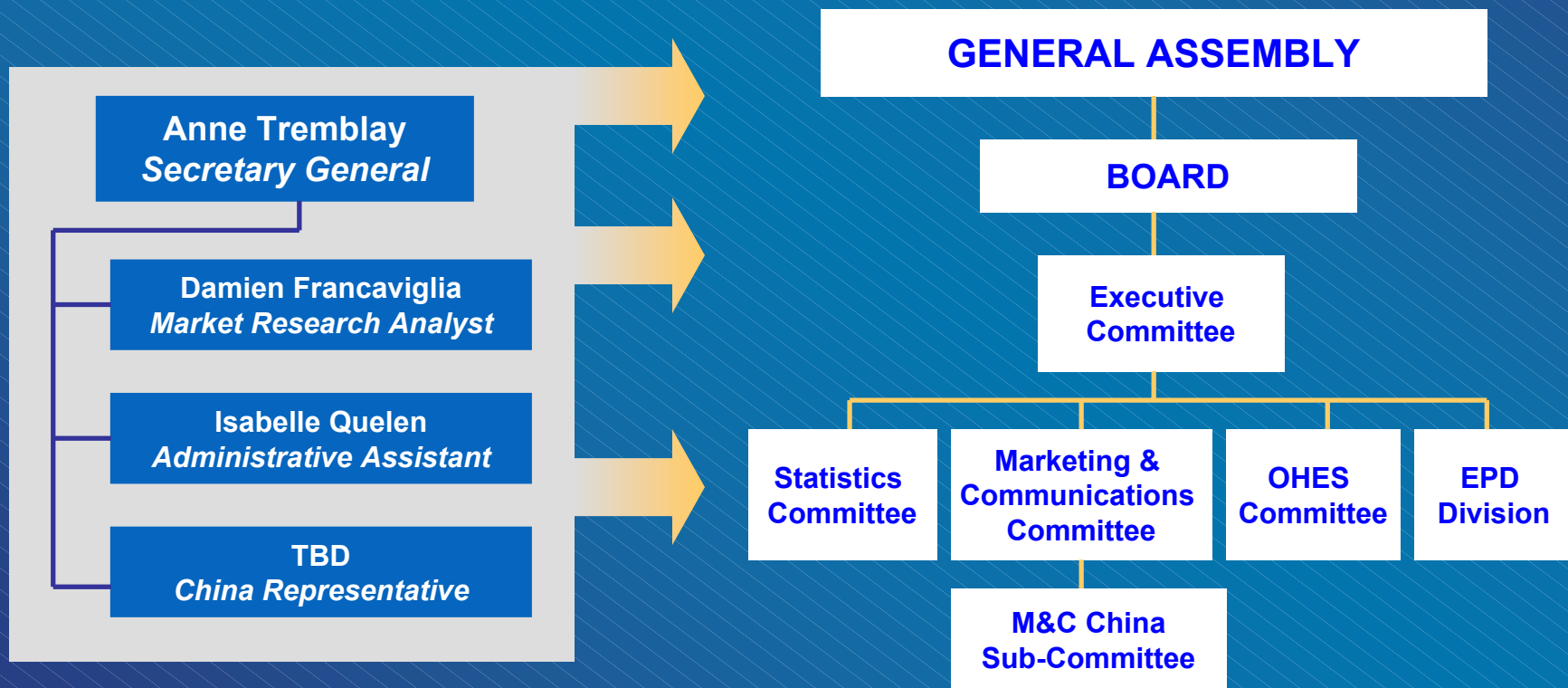
- Encourage co-operation within the industry by providing its leaders with decision-making tools and an open forum for discussion
